- 1- The Reform Support Unit, School Education Department, Government of Sindh has received a Grant from Global Partnership for Education toward the cost of Supply and Purchasing of Inverter Split Type Air Conditioners for Monitoring & Evaluation (M&E) Units of Sindh and it intends to apply part of the proceeds of this grant to payments under the agreement(s) resulting from this IFB: PROC: /S-GPE/M&E/AC/NCB-2017.
- 2- The Reform Support Unit *on behalf of DG-M&E, School Education Department, Government of Sindh and Data Center School Education Department* now invites sealed bids from eligible Bidders for Supply, Installation and Commissioning of Inverter Split Type Air Conditioners as under :

The eligibility criteria for the assignment are as follows:

1. *The bidder should be either OEM for Inverter Split type Air conditioners or its authorized dealer.*
  2. *The bidder or Manufacturer must have at least ten (10) years' experience & adequate facilities and capabilities in supply of required inverter split type air conditioners.*
  3. *The bidder or Manufacturer must have done at least Ten (10) Contacts of similar nature and magnitude.*
  4. *The Bidder should not have been barred by any of Provincial or Federal Govt. Deptt., Agency, Organization or autonomous body or Private sector organization anywhere in Pakistan.*
  5. *The bidder must have turnover/sales exceeding 30 Million in PKR annually in each consecutive past three years.*
  6. *The bidder must have service centers in at least 03 major cities of the province*
- 3- A complete set of bidding documents may be obtained by any interested eligible bidder on the submission of a written application to the above office and upon payment of a non-refundable amount of Rs. 1000/- (One thousand only) in the form of a Demand Draft / Pay Order in favour of Chief Program Manager, Reform Support Unit, School Education Department, Government of Sindh or can be downloaded from the Website [www.rsu-sindh.gov.pk/](http://www.rsu-sindh.gov.pk/) & <http://www.procurementrsu.com>. Bidders who download the document from Website and wish to participate in the bid, will be required to submit the cost of the bid document at the time of bid submission otherwise the bid will be considered non responsive.
  - 4- The Provision in the Instruction to Bidders in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Document: Procurement of Goods for National Competitive Bidding, Pakistan*, Part One. Procurement shall be done through National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of Guidelines Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011).
